We feel really good about our Financial Condition – Louis will provide more specifics

- Ended 2017 with about \$36,000, up about \$6,000 from a year earlier
- Expenses will be \$30,000 in 2018.
- We did keep dues the same year at \$135. However, to help encourage on-time payment we offered a \$10 discount to those that paid by June 1st
  - Note that every 1,000 in expenses is about \$4.50 to every homeowner
- Maintenance Renovation is complete
  - $2^{nd}$  year with our new vendor
  - Feedback generally positive
